**INVITATION FOR NEGOTIATED PROCUREMENT**

As a result of two (2) failed public bidding, the Philippine National Police Logistics Support Service-Bids and Awards Committee (LSS-BAC) through the Annual Procurement Plan for CY 2015 intends to apply the sum of Nineteen Million One Hundred Thirty Four Thousand Pesos (P19,134,000.00) for the **Negotiated Procurement** of the item below.

The LSS Bids and Awards Committee (LSS BAC) now invites prospective proponents/suppliers to submit Price Quotations for the supply and delivery of 3,826 Ctg. 40mm HE LV.

The goods must be delivered within ninety (90) calendar days upon receipt of the Notice to Proceed.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.


Information may be obtained from the LSS BAC Secretariat and inspect the negotiation requirement at the address given below from 8:00AM to 5:00PM.

**Price Quotations must be delivered at the PNP LSS Conference Room, 2<sup>nd</sup> Floor, PNP LSS Building Camp Crame, Quezon City on or before January 14, 2016 at 9:00A.M.** Price Quotation will be opened in the presence of the bidders authorized representative who choose to attend at the address abovementioned. The authorized representative must be present during the opening of price quotations. Price Quotation submitted after the deadline shall not be accepted. The following documents shall be included:

1. Letter of Intent;
2. SEC/DTI/CDA Registration Certificate;
3. Mayor's Permit;
4. Latest Audited Financial Statement stamped "RECEIVED" at least on one page;
5. Statement of all its on-going and completed government and private contracts;
6. Proof of Single Largest Similar Contract (SLSC);
7. Tax Clearance;
8. Conformity with Technical Specifications;
9. Conformity with the Delivery Schedule;
10. Certificate of PhilGEPS Registration; and
11. Omnibus Sworn Statement;

Bids in excess of the ABC shall be automatically rejected during the opening of bids.

PNP LSS-BAC reserves the right to waive any formality in the response to the eligibility requirements and to this invitation. The PNP LSS-BAC further reserves the right to reject any and all proposals, or declare a failure of bidding, to award the contract to any bidder whose bid is considered most advantageous to the government, or not award the contract, and makes no assurance that contract shall be entered into as a result of this invitation without thereby incurring any liability to the affected Bidder or Bidders.
