## **Invitation to Bid PNP ITB No. 2020-03**

1. The Philippine National Police intends to dispose through sale, **One Lot of 98 units Beyond Economical Repair (BER) Mobility Items** stored at the LSS Disposal Yard, Camp Bagong Diwa, Bicutan, Taguig City with a minimum selling price of Four Hundred Ninety-Two Thousand Four Hundred Sixteen Pesos (Php492,416.00).
2. The Philippine National Police now invites bids for the aforementioned project. The sale will be on **“as is, where is”** basis, subject to the General Terms and Conditions for the sale of government property (Copy attached). Hauling of the items shall be done within 30 days from the winning buyer’s receipt of the Notice to Proceed.
3. Auction will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion. Auction is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

5. Pre-bid conference will be conducted through teleconference on **June 11, 2020** at 2:00 PM at DL Conference Room (Host), Camp BGen Rafael T Crame, Quezon City. Interested buyers may opt to join the teleconference for clarifications on the sale of subject BER properties.
6. Viewing of the items subject of the disposal shall be available to all prospective buyers on **June 3 to 10, 2020** from 8:00 AM to 5:00 PM at LSS Disposal Yard, Camp Bagong Diwa, Bicutan, Taguig City.
7. Bids must be duly received by the NHQ Disposal Committee Secretariat at the address below on **June 16, 2020 not later than 2:00 PM**. All Bids must be accompanied by a bid security using the required form in the Bid Data Sheet.

Auction/bid opening shall be on **June 16, 2020** at exactly **2:00 PM** at the PNP DL Conference Room, Ground Floor PNP NHQ Building, Camp BGen Rafael T Crame, Quezon City. Bids will be opened in the presence of the buyer or his/her authorized representative, if any. Late bids shall not be accepted.

8. The Philippine National Police reserves the right to reject any and all bids, declare a failure of bidding, waive any defect contained therein, or accept the offer which is most advantageous to the government.
