Bidding shall be conducted through open competitive bidding using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens sole proprietorship/partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

The complete set of Bidding Documents may be acquired by Interested Bidders on **September 30, 2020** onwards, from 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays on the address stated below upon payment of a non-refundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity at [www.lss.pnp.gov.ph](http://www.lss.pnp.gov.ph), provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the date of submission of bids.

Bid Opening is on **October 7, 2020 (Wednesday) at 9:00 A.M.** at the LSS Multi Purpose Hall, 4<sup>th</sup> Floor PNP LSS Building, Camp BGen Rafael T Crame, Q.C. Bids shall be opened in the presence of the bidders' authorized representatives who will attend the said activity at the address provided above. Late bids shall not be accepted.

The LSS-BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
