Invitation to Bid for the Supply and Delivery of Goods

The Logistics Support Service Bids and Awards Committee (LSS BAC) through Certificate of Availability of Funds (CAF) dated September 24, 2020, intends to apply for the public bidding of the following items:

The LSS BAC now invites bids for the aforesaid Goods. The goods must be delivered within the specified number of days indicated in the Bidding Documents for the item upon receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of bid submission and receipt of bids, a contract similar to the Project.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

A complete set of Bidding Documents may be purchased by Interested Bidders on **November 18, 2020** onwards, 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays from the address below upon payment of a non-refundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The LSS-BAC will hold a **Pre-Bid Conference** on **November 24, 2020**, at **9:00 A.M.** at the LSS Conference Room, 2nd Floor PNP LSS Building, Camp BGen Rafael T Crame, Q.C. which shall be open to all interested parties.

Opening of Bids shall be on **December 7, 2020** at **2:00 P.M.** at the LSS Conference Room, 2nd Floor PNP LSS Building, Camp BGen Rafael T Crame, Q.C. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The LSS-BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
