Bidding shall be conducted through open competitive bidding using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens sole proprietorship/partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

The complete set of Bidding Documents may be acquired by Interested Bidders on **March 31, 2021** onwards, from 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays on the address stated upon payment of a non-refundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity at www.lss.pnp.gov.ph, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the date of submission of bids.

Bid Opening is on **April 7, 2021 (Wednesday) at 9:00 A.M.** at the LSS Multi Purpose Hall, 4th Floor PNP LSS Building, Camp BGen Rafael T Crame, Q.C. Bids shall be opened in the presence of the bidders' authorized representatives who will attend at the said activity at the address provided above. Late bids shall not be accepted.

Bidding shall be conducted through open competitive bidding using a non-transactional system. The system shall be approved in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9154. Likewise, known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens and corporations organized under the laws of the Philippines, and to citizens or organizations of a country belonging to a group of states which have entered into a treaty or agreement with the Philippines for the purpose of giving the right of preference to Filipino citizens, pursuant to RA 9154 and subject to Commonwealth Act 108.

The complete set of Bidding Documents may be acquired by interested bidders on March 21, 2021, between 9:00 AM to 5:00 PM (except Saturdays, Sundays and public holidays) at the address stated, and available for the bidders to acquire on Bidding Documents.
