The complete set of Bidding Documents may be acquired by Interested Bidders on **March 5, 2021** onwards, from 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays on the address stated upon payment of a non-refundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity at www.lss.pnp.gov.ph, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the date of submission of bids.

Bid Opening is on **March 12, 2021 (Friday) at 9:00 A.M.** at the LSS Multi Purpose Hall, 4th Floor PNP LSS Building, Camp BGen Rafael T Crame, Q.C. Bids shall be opened in the presence of the bidders' authorized representatives who will attend at the said activity at the address provided above. Late bids shall not be accepted.

The LSS-BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
