Bidding shall be conducted through open competitive bidding using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens sole proprietorship/partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

The complete set of Bidding Documents may be acquired by Interested Bidders on **March 16, 2021** onwards, from 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays on the address stated upon payment of a non-refundable fee for the Bidding Documents.
