Bidding shall be conducted through open competitive bidding using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens sole proprietorship/partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

The complete set of Bidding Documents may be acquired by Interested Bidders on **April 23, 2021** onwards, from 8:00 AM to 5:00 PM except Saturdays, Sundays and Holidays on the address stated upon payment of a non-refundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity at www.lss.pnp.gov.ph, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the date of submission of bids.

Bidding shall be conducted through open competitive bidding using a non-automated process, unless otherwise specified in the Revised Procurement Rules and Regulations (RPR) of Republic Act (RA) 9184 otherwise known as the Government Procurement Reform Act.

Bidding is restricted to Filipino citizens who are duly registered and organized with at least fifty percent (50%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens. RA 9184 and subject to Department Order (DO) 132.

The complete set of Bidding Documents may be acquired by interested bidders on April 13, 2021 onwards from 9:00 AM to 5:00 PM, except Saturdays, Sundays and Holidays or the relevant state (non-payment) and non-functional for the Bidding Documents.

If any bid is downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and in the website of the Procuring Entity at www.lps.gov.ph, bidders shall bid and pay the non-refundable fee for the Bidding Documents not later than the date of submission of bids.

The LSS BAC will hold a Pre-Bid Conference on **April 30, 2021 (Friday) at 9:00 A.M** at the LSS Multi Purpose Hall, 4th Floor PNP LSS Building, Camp BGen Rafael T Crame, Q.C.
