SUPPLEMENTAL BID BULLETIN NO. 2021-01

This Supplemental Bid Bulletin is issued to clarify certain matters on the published Invitation to Bid Nos. 2021-03 to 06 on the PNP Website and LSS Website on September 22, 2021, the Final Submission and Opening of Bids of which is on October 7, 2021 at 10:00 AM.

PNP ITB No. 2021-03 to 06 Disposal of BER Items and Scrap Materials. The date of Pre-Bid Conference should be on September 30, 2021 at 2:00 PM via Zoom (Meeting ID: 87627187274 Passcode: LSSDC) and not September 30, 2021 at 10:00 AM at the LSS Multi Purpose Hall.


Further, **supplemental to the instruction to Bidders**, bidders/buyers shall submit in sealed envelopes **Two (2) SETS** of the **FIRST** and **SECOND** components of its bid. Photocopies are accepted provided that each and every page of the documents bears the signature of the bidder/buyer or his/her authorized representative. Provided, however, that the original of the documents shall be required to be presented during the evaluation to be conducted by the TWG.

Packaging of Folders/Envelops: All sets of documents/folders:

1. The folder of the original/authenticated copies must be marked "ORIGINAL" and the photocopy, which must be signed in every page by the bidder/authorized representative and be marked "COPY 1" and "COPY 2";
2. All folders must contain a Table of Contents/Checklist listing down the different documents submitted which shall serve as cover for every set of documents/folders;
3. Arranged according to the sequence by which the same are listed in the Table of Contents;
4. Tabbed to easily identify/locate each type of document. One tabbing must be placed for every document and each set of documents must have its own sequential tabbing; and
5. Failure to comply with the requirements will be a ground for disqualification.

The envelops shall bear the note: **"DO NOT OPEN UNTIL OCTOBER 7, 2021 at 10:00 AM"** (deadline for the submission of bids).
